**CLASS ORDER:**

<b>1. NON PRO BRIDLE</b>	<b>JACKPOT</b>	<b>FENCE</b>	<b>\$125</b>
A NON PRO is defined as anyone who is not currently receiving remuneration directly or indirectly for training, showing, giving lessons, clinics or assisting in the training of a horse for remuneration. Horses must be owned by exhibitor or exhibitor's family (spouse, child, stepchild, parent, grandparent, grandchild, step-parent, sibling, half-sibling, spouse's parent, spouse's step-parent, sibling's spouse, half sibling's spouse, step-sibling's spouse), legal ward or legal guardian.			
<b>2. OPEN BRIDLE HORSE</b>	<b>JACKPOT</b>	<b>FENCE</b>	<b>\$125</b>
Open bridle horses only.			
<b>3. GREEN BRIDLE/TWO REIN</b>	<b>JACKPOT</b>	<b>FENCE</b>	<b>\$125</b>
If shown in two rein, horses of any age not shown in the bridle down the fence in any judged event prior to 11-16 of the current show year. Green Bridle horses not to have been shown in the Bridle prior to 1-1 of the current year.			
<b>4. BUCKAROO NON PRO RIDERS ONLY</b>	<b>JACKPOT</b>	<b>BOX</b>	<b>\$125</b>
Horses 5 and under may be shown in snaffle bit (4 & Under) or hackamore (5 & Under) at rider's discretion. Rider may not have gone down the fence 3 times in any judged reined cow horse event held at any time, at any place.			
<b>5. YOUTH STOCKHORSE</b>	<b>POINTS ONLY</b>	<b>BOX</b>	<b>\$70</b>
Horses 5 and under may be shown in snaffle bit or hackamore at rider's discretion. Horses of any age may be shown in the two rein for 1 year only or in the bridle.			
<b>6. OPEN HACKAMORE</b>	<b>JACKPOT</b>	<b>FENCE</b>	<b>\$125</b>
Open to horses not over 5 yrs old as of 1-1 that have never been shown in a bridle or two rein down the fence.			
<b>7. NON PRO SNAFFLE BIT/HACKAMORE</b>	<b>JACKPOT</b>	<b>FENCE</b>	<b>\$125</b>
See rules governing OPEN SNAFFLE BIT AND OPEN HACKAMORE for age restrictions			
<b>8. OPEN SNAFFLE BIT</b>	<b>JACKPOT</b>	<b>FENCE</b>	<b>\$125</b>
Open to horses 4 and younger never shown other than in a snaffle bit down the fence.			

Nevada Reined Cow & Cutting Horse Association rules to apply to all classes: chaps, leather chin straps, spade bits or other NRCHA approved bit to be used. Owners and riders must be current NRC&CHA members.
